1. Call to Order

The meeting was called to order at 6:35pm by Chairman Nobile.

3. Approval of Agenda

A motion was made by Paul Warenda and seconded by Robert Donohue to approve the agenda. All were in favor; the motion passed.

4. Public Comments

Bob Crawford, Manager at Champions Skating Center said he was the owner there for 26 years but about a year and a half ago he was approached by Black Bear group to purchase and he did sell to them. He said we host major tournaments every month and we are probably the reason for the new hotels in the area. Mr. Crawford said they are a regular ice skating rink; a figure skating rink and we have a full size swimming pool. He said we are also a full gym that offers classes as well. He said Black Bear wants us to get out there and let people know about what we have to offer and we are looking for ways to engage with the community. Mr. Crawford said I am asking for your help to engage with the Cromwell Park and Rec Department so we can run programs with them. He handed out flyers to the Commissioners. Mr. Nobile said you need to establish a

relationship with the Park and Rec department and swimming is the best way to get involved since that is like a hidden secret you have there. Mr. Cambareri said they did see an increase in our business when you had events. Mr. Popper told Mr. Crawford that he just texted the Town Manager, Mr. Salvatore, and he said you should contact him. Mr. Polke asked if they were members of the Middlesex County Chamber of Commerce and Mr. Crawford said he believes they are. Mr. Nobile said this is an advisory Commission and we are happy to support your ideas.

5. Director of Planning and Development Report

Mr. Popper reviewed his memo dated October 5, 2023. There was a discussion on the Sebethe Drive application and Mr. Popper said we will push the tenants there to clean up their sites. He said the Town Council approved the tax abatement for 100 Berlin Road and they expect to begin demolition in the Spring. Mr. Popper showed the article in the Hartford Business Journal about Martin Kenney and the succession plan. Mr. Cambareri told Mr. Popper that he did a great job with this and it is a long time coming. Mr. Nobile said the town efforts were good and the applicant for 100 Berlin Road did a great job with their presentation. He said he thanks the councilmen who voted yes on this and said Mr. Popper can't get enough credit for this.
