General discussion to help clarify the purpose of a cultural district, and some of the history of both creative districts (initiated by National Endowment for the Arts (NEA) and CT State Cultural Districts, was held prior to selection of officers. The distinction between Cromwell Creative District and Cromwell Cultural District Commission is a work in progress with the goal to work collaboratively and create clarifications after application and approval by state is received.

AG clarified that even though an ordinance was passed by Cromwell Town Council creating CCDC, there is no cultural district in Cromwell until an application has been sent to state and state has approved. Packets with baseline information required for application were handed to all.
