E. CHIEF SALVATORE'S REPORT

Monthly statistics were handed out for the months of October and November. Chairman Newton, on behalf of the Police Commission, congratulated Chief Salvatore for receiving the MADD Award.

- Chief Salvatore stated that he is pleased to report the Cromwell Police Department's 2011 Food Drive at Stop & Shop was even more successful than last year's event. An amazing amount of food was collected along with \$273.00 in cash and \$215.00 in gift cards. All that was collected was turned over to Cromwell's Human Services Department. Chief Salvatore thanked the entire department for making this program a success. Chief Salvatore specifically thanked Stop & Shop, Captain Kosinski and Lori Labbadia for their efforts.
- Chief Salvatore also recognized the Police Department for the fantastic job they did handling the recent extended power outage caused by the snow storm. Chief Salvatore also complemented the Fire Department and the entire Public Works Staff for the fine job they did handling the storm.
- Chief Salvatore reported that there were two robberies on Main Street and Webster Bank was robbed. The Department continues to work on the three cases. The FBI is assisting with the Webster Bank robbery.
- One area of complaint that was brought to the Chief's attention during the storm was the lack of having the means to keep the public informed of services that were available to the public. Chief Salvatore stated that during the budget process he will bring back his request to participate in the Everbridge System. If approved it will enable notices to be sent out to the public during emergency situations.
- Chief Salvatore reported that the Department was granted a spot in the July session of the FBI National Academy. Chief Salvatore discussed this opportunity with First Selectman Terry and received her approval to send Captain Kosinski to the July Academy.
