b. Library Director: Director Canney reported the following:

Director Canney spoke with the Town Manager on Friday, July 10. Mayor Enzo Faienza and the Cromwell Library Commission are aware of the Library's plans to reopen on August 3, 2020. Of the other Connecticut Libraries, 78 are open, and 112 remain closed at the time of this meeting. It is imperative that the Cromwell Library Staff feels safe, protected, and comfortable with reopening. Since last meeting, it was decided that computers will not be available for use to Library Patrons upon first reopening. No

more than 20-25 Patrons at a time will be allowed inside the Library. Pop-up tent events at the Library continue, as well as curbside pick-up. The Summer Reading Program is popular, as well as the Family Read-Aloud Program.

Martha Rennie made a motion to accept the Director's Report as given; Seconded by Karen Spotts. *All in favor. Motion passed.*

c. Finance Report: Director Canney reported that the Library has started the new fiscal year in great shape, and plans to email the 2019-2020 Fiscal Year Report to the Cromwell Library Commission Members. Director Canney stated that the decrease in Circulation is to be expected, and is pleased with the Library's Virtual Programming. Director Canney plans to meet with Librarians from the Hartford area regarding best practices in virtual programming, and to share resources among these area Libraries.
