Vice Chairwoman Halibozek called the meeting to order at 6:07pm.

5. Old Business

a. Tank Farm – Chevron cleanup

Mr. Popper said that there has been no news on the tank form. Mr. Warena said is not aware of any changes either.

b. 60 and 61 River Road RFQ/RFP

Mr. Popper said nothing new here either.

c. Former Public Works Facility

Mr. Popper asked Mr. Waters if there was anything new going on and Mr. Waters said nothing new. Mr. Popper asked if there has been a site selection for the Community Center and Mr. Waters said no. Mr. Popper said they are moving with the sidewalk installation from West Street to the park and the realignment of West Street and Lincoln Street and Allen Street and West Street. He said there will be a mandatory referral in front of the Planning and Zoning Commission next week and we are using the bond money we received for that project.

6. New Business:

Mr. Popper said that Arbor Meadows is in the last phase of construction and a revised application for the Texas Roadhouse will be submitted in March. He said they made some changes that resulted in a change to the site plan. Mr. Popper said the Economic Development Commission will hear the presentation from the 100 Berlin Road developer for a tax abatement request. He said if the Commission recommends the abatement then it will go to the March 8th Town Council Meeting. He said a medical office building at 80 Shunpike Road was approved and the occupants will be Middlesex Health so that is good to welcome them to Cromwell. He said the TPC will come to Planning and Zoning with an application for their big event.
