# Senior/Human Services Director's Report - Amy Saada

Budget update - money will be spent by July 1, 2017.

Grants/Funding - Amy will be attending a workshop on June 13, 2017 for the Middlesex Community Foundation. She will apply for a grant for iPads and for minor home repairs.

Mertie Terry inquired about computer classes. They are being held at the library on Wednesday from 10:00-11:00 am.

Mertie Terry inquired about the movies. Amy advised that there are movies every Friday.

Amy should hear very soon about the bus grant.

New programs – There will be a YMCA strength class, weekend outings and an additional day of pickle ball. Beginning in July, Autumn Lake will sponsor monthly birthday cake. Autumn Lake will also sponsor a monthly sign-along (first Friday of the month) with the hopes to start a choral group. Wadsworth Glen will provide lunch during the police department presentation on scams on July 17, 2017. Barnum Financial will sponsor a "lunch and learn" the last Tuesday of every month starting in July.

The senior dinners are scheduled for October 19, 2017, March 15, 2018 and June 21, 2018.

The challenges are parking issues and that outreach needs are not being met as 35% of the population is over age 60. (Amy mentioned the need for an outreach coordinator). Amy is also struggling to find volunteers to lead group programs. Program capacity is also an issue as many exercise programs are full.

The donation account is currently \$24,688.00

## Director of Public Health Update - Wesley Bell

The mosquito program is going full board which will impact the number of mosquitos. The mosquitos that carry the zika virus are in/around a house. People need to dump items that collect water (bird baths, dog bowls, etc.). Brook areas are ok if the water is running.

The gypsy moths are not a health issues. Organic sprays can be applied to trees; the moth then needs to eat the leaf to die. Need to reapply after rain.

The fall flu clinic is scheduled for October 25, 2017 in the town hall gym. No copayment is required; bring ID and medical card. It will be a pure protein vaccine.
