3. Construction continues with Phase IV and V of the 75 lot Arbors Meadows Subdivision on Field Road.

Commercial Development:

We continue to see renovation, expansion and construction of commercial properties these include:

1. The Texas Roadhouse Restaurant at 51 Shunpike Road
2. The 26,000 square foot, two story medical office building at 80 Shunpike Road.
3. New Morecon Construction contractor's building at 70 County Line Drive.

1. Application #23-13: Request for a Special Permit to allow for a restaurant with alcoholic beverages at 35A Berlin Road in the Former Joe's Filling Station. Kemal Cecunyanin is the Applicant.
2. Application #23-14: Request for a Special Permit to allow for restaurant with alcoholic beverages at 530 Main Street in the former Gyro Restaurant. Brian Bonneau is the Applicant.

2. Request to construct an AutoZone at 48 Berlin Road. (Former Friendly's location)

A motion was made by Paul Warenda and seconded by Richard Nobile to approve the minutes of March 15, 2023. All were in favor; the motion passed.

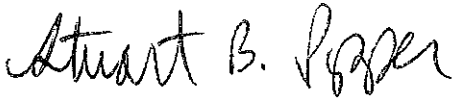
8. Commissioner's Comments:
