Senior/Human Services Director's Report - Amy Saada

Amy provided grant information:

- Awarded \$2880 grant for Tai Ji Quan.
- Awaiting announcement on Community Foundation of Middlesex County Grant for new electronic Bingo machine and display board.
- Awarded 100% DOT5310 funding for a new bus (expected delivery summer 2023).

It has been a busy month. There are still several upcoming December programs:

- December 14th Snack & Learn signs and stages of dementia
- December 15th at 2:30 Drama club presentation of "Scrooge...A Comedy?"
- December 21st Magic Lights tour at Rentschler field with dinner at Maggie McFly's; there are 2 buses for this trip and there is currently a waiting list

- December 28th Lunch at the Hangry Goose and Fantasy of Trees at the Florence Griswold Museum; this trip is almost full
- December 30th The Great Senior Bake Off; rules are listed in the newsletter

Amy is working with Friendship Tours and expects to have a complete list in January. There is a Florida/Bahamas cruise scheduled for October 15-22nd (8 days/7nights for \$749) and "Spring is in the Air" lunch and show outing at the Chowder Pot on April 27th for \$74.

The transportation update shows that many of the vehicles are getting past their "useful life" (5 years or 150,000 miles, whichever comes first, per the DOT). As of November 30, 2022:

There was a lot of discussion about the new community center. A construction manager for the school project has been selected.

Paula said that Steve did a great job. The meeting was almost 2 hours long and there were lots of questions. The mayor would like to do this again.

Judy Benvenuto advised the Commission that someone mentioned the empty meeting room in the library and Steve said he will look into this.

Old Business - Amy Saada

a. Community Center Discussion/Updates

This was previously discussed during the Council Liaison update. The Town Manager was also in attendance for the "Coffee with the Mayor".

Amy will work with John Harriman to apply for grant funding through the USDA. The application deadline is February 28, 2023. There is no median income requirement. Amy said that the grant is "very broad" and could be used for land, design work, etc.

Per Deirdre Daly, the Town Manager mentioned that the Water Department has land on Coles Road. Al Waters advised that they were going to sell the land for \$350,000. The land is there and still a possibility.
