as surety are held and firmly bound unto THE TOWN OF CROMWELL, in the sum of Five Thousand Dollars (\$5,000), lawful money of the United States of America to be paid to the said TOWN OF CROMWELL, its respective successors or assigns, for which payment, well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

The condition of this obligation is such. That whereas the above bounded principal has by The State of Connecticut, Department of Consumer Protection, Board of Occupational Licensing been issued a license as anumber.....effective.....and expiring on.....
and whereas the Town of Cromwell by its Water Pollution Control Authority has issued a permit or permits to perform the work allowed by said license for the period beginning.....and ending on.....

Now, Therefore, if the said.....
shall well and truly keep and perform, during said term, all the terms and conditions of the ordinances, resolutions, rules and regulations of the said Town of Cromwell, and its Water Pollution Control Authority regulating the laying of Town sewers and drains, sewer house connections, private drains and appurtenances, and shall forever indemnify and save harmless The Town of Cromwell and any of its officers or agents for or on account of any damages to property of any person or persons or any damage to the sewer system of The Town of Cromwell in consequence of or resulting from any work performed by said
principal.....servants or agents, or of, or from any negligence regarding said work, or of, or from any act or omission of said principal.....
servants or agents until the expiration of the two year maintenance period; shall reimburse the Town of Cromwell for any expense to said Town or its agents arising from any injury or damage to any sewer or drain or other property of said Town or be reason of any violation by the principal.....
agents or employees of any requirement of said ordinance; shall faithfully perform said work in all respects and shall also replace and restore that portion of any street or any excavation, to as good condition as that in which the same was before said work was performed, and shall also keep and maintain such street or other property in like good condition to the satisfaction of the First Selectman of the Town of Cromwell or his authorized agent for the period of not less than two years after completing said work, and , should the said principal, repair said portion of such street or other property, the principal shall pay the cost thereof within thirty (30) days, and shall comply in all respects with the rules and regulations established by the Town and its Water Pollution Control Authority relative to such work, and the terms of the permits that may be issued to him, and shall also pay all fines or penalties imposed upon him for violation of any such rule or regulations, then this obligation shall be of no effect; otherwise, it shall remain in full force and virtue.
