A. Call To Order

Chairman Michael Camilleri called the meeting to order at 6:00.

B. Approval of Agenda

Chairman Michael Camilleri asked for a motion to approve the agenda. Shirley Banic made a **motion** to approve the agenda. Paul Beaulieu **seconded** the motion. *All were in favor; the motion passed*.

C. Approval of Minutes

1. Regular Meeting June 8th, 2016

Karen Spotts recommended a few language changes to ensure clarity. Paul Beaulieu made a **motion** to approve the minutes as amended for the meeting on June 8th, 2016. Shirley Banic **seconded** the motion. *All were in favor; the motion passed*.

D. Public Comments

There were no public comments at this time.

E. Old Business

- 1. Review Charter Revision recommendations
- a. Changes to the sizes of various Boards and Commissions (For reference, please see Charter Sections 4.17, 5.02, 5.10, 5.11)

Karen Spotts created a chart of the various boards and commissions and their current sizes (See Attachment). The commission reviewed the current sizes of boards and discussed the necessity of the number of members.

Karen Spotts explained that the Senior Services Commission could be reduced to 7 members as per Town Manager Anthony Salvatore's recommendation. At Chairman

Camilleri's request, each member stated their position on reducing the Senior Services Commission.

Paul Beaulieu stated that he did not have a preference. Michael Cannata stated that if the commission is not having any issues reaching a quorum then we should not change it. Shirley Banic and Karen Spotts agreed with Michael Cannata that if it is not broken, then they should not fix it.

Karen Spotts raised the issue of overlap between the Youth Services Advisory Board and the Park and Recreation Committee. It was also raised that the titles of the boards may be in conflict among the charter and town ordinances. There was also a discussion of the separation of the Park and the Recreation aspects of the board because they are overseen by different departments, the Public Works department and Parks and Recreation respectively. The Youth Services Advisory Board is governed by both state statute and administrative ordinances making it a complex issue to tackle. Michael Camilleri suggested returning to this topic after discussing it with further with Town Manager Anthony Salvatore.

Chairman Camilleri also suggested discussing the various committees with Mr. Salvatore to review the topic and role of advisory commissions. A discussion then ensued regarding the importance and roles of various commissions. Chairman Camilleri stated that for the next meeting the commission will review the purpose and role of the Recreation and Youth Services Commission, Economic Development Commission, Conservation Commission, Library Services Commission, Senior Services Commission.

b. Board of Finance and Budget Referendums (For reference, please see Charter Sections 5.02 and 5.08 and Article VIII).

Chairman Camilleri reviewed the informal vote taken at the last meeting. Between meetings, the commission has reviewed 8 or so different charters of various Connecticut Towns to understand how the budget process works in other towns (See Attachment). Karen Spotts created a draft flow chart of each town's budget process for the commission to review (See Attachment). She said that she saw some good language in other town charters that may be preferable. Michael Cannata raised the point that it seems many of the other towns start their budget process with the Finance Department and the Town Manager but then it moves down the chain and does not go back under their review. A discussion ensued about how the various budget processes include or exclude the Town Manager and other officials.

Anthony Amenta suggested a joint meeting with the Board of Finance and the Town Council to hear the Department presentations and have the Board of Finance provide an advisory role to the Town Council decision. Paul Beaulieu stated that he prefers to have a

joint meeting. Shirley Banic agrees. There is consensus among the commission that there should be a joint meeting.

Michael Cannata stated that he prefers to see the Board of Finance have the final say because they are the specialists and they are less likely to be politically motivated.

At the Chairman's request, each member stated their opinion on maintaining the referendum.

Michael Cannata stated that he is in favor of maintaining the referendum. Paul Beaulieu stated that he supported maintaining the referendum with a few tweaks. Karen Spotts, Shirley Banic, and Anthony Amenta agreed with Mr. Beaulieu.

Michael Cannata stated that he is against limiting the number of referendums unless there is a threshold. A discussion ensued about the what that threshold might be.

Anthony Amenta spoke about the idea of not fixing something that isn't broken.

c. Other proposed revisions in working draft of Charter

No other revisions discussed at this time.

F. New Business

- 1. Discuss game plan for review and revisions to remaining Charter provisions
- 2. Set discussion topics for next meeting.

Prior to Chairman Camilleri's departure, he asked to discuss the dates of the July meetings. Currently, the July meetings are scheduled for July 6th and July 20th. The commission agreed to hold a meeting on July 13th at 6:00 pm. For the next meeting, Paul Beaulieu suggested discussing the Water Pollution Control Authority under New Business.

G. Adjournment

Karen Spotts made a **motion** to adjourn the meeting. Shirley Banic **seconded** the motion. *All were in favor; the motion passed.* The meeting was adjourned at 7:45 pm.
