The meeting was called to order by Acting Chairman Whitney at 7:55 p.m.

Mr. Popper said that the Conservation Commission was designated as the Sustainability Commission for the town. He had submitted information to the Sustainable Connecticut Municipal Certification Program and was working on getting more information about the program so Cromwell could become a Certified Community and he would pass that information along upon receipt. Amanda Drew asked how many towns were certified and Mr. Popper said more than twenty. Acting Chairman Whitney asked if Cromwell still had the farmland preservation designation and was told yes.

9. Commissioners' Comments: None


10. Public Comments: There were no public comments at this time.
