I am writing to inform you that in accordance with the amended lease between the Town of Cromwell and the Cromwell Outboard Association, Section 6, Use of Premises, I will be requesting permission from the Town Council at their next Regular or Special Meeting to use the parking area commonly referred to as Two (2) River Road for parking for the Town of Cromwell Summer Concert Series. 
The Concert Dates are as follows:
