The entire plan will also be adopted by the RiverCOG board once all municipal annexes are adopted.

Natural Hazard Mitigation Plan 2021 Update

Frequently Asked Adoption Questions

Q 1. What is hazard mitigation?

Answer: Unlike disaster response or recovery, hazard mitigation is proactive. In general terms, hazard mitigation is any sustained action taken to reduce injury, loss of life and damage to infrastructure, property and the environment during future disasters. Hazard mitigation also should reduce the need to respond to disasters and the financial burden of responding and recovering.

Q 2. Why are we adopting the updated NHMP?

Answer: The federal Disaster Mitigation Act of 2000 (DMA 2000) (Public Law 106-390), commonly known as the 2000 Stafford Act amendments, was approved by Congress on October 10, 2000. Along with other specifications, this act required state and local governments to develop hazard mitigation plans as a condition for federal grant assistance—reinforcing the importance of predisaster infrastructure mitigation planning to reduce disaster losses nationwide. DMA 2000 is aimed primarily at controlling and streamlining administration of federal disaster relief and programs to promote mitigation activities. Prior to 2000, federal legislation had provided funding for disaster relief, recovery, and some hazard mitigation planning; however, DMA 2000 improved upon the planning process by emphasizing the importance of communities planning for disasters before they occur.

Q 2. What funding sources are available to implement the plan?

Currently an updated, approved and fully adopted plan is required for the following FEMA grant programs:

- Building Resilient Infrastructure and Communities (BRIC) this is an annual grant program
 targeted at infrastructure and building projects that make a community more resilient.
 Community Capacity and Capability Building grants are also available for planning and
 studies. Proposed funding for the next cycle is \$1 Billion.
- Hazard Mitigation Grant Program (HMGP) this is a post disaster program that provides
 mitigation planning and project grants equal to 15% of the total disaster damages in the
 Presidentially declared disaster area. It has historically been Connecticut's largest source of
 mitigation funding
- Flood Mitigation Assistance Program (FMA) is an annual grant program specifically targeted at projects that prevent damages to NFIP insured properties.

There are numerous other funding programs from the federal and state government for resilience and mitigation projects. While they may not all require a mitigation plan. Having carefully chosen, publicly endorsed and well thought out mitigation actions in the plan will most certainly help with grant procurement.



Q 3. How often does the plan require updating?

In order not to lapse, the plan must be updated every five years. It typically takes one year of planning to obtain a grant to update the plan and approximately one year to complete the update.

Q 4. What happens if we are unable to obtain funds to implement the plan?

Participating in the update, identifying mitigation projects and adopting the plan does not commit the community to its implementation if funding is not available. Circumstances change as do programs and priorities. There is no penalty for failing to implement the projects and strategies identified in the plan.

WHEREAS the Lower Connecticut River Valley Council of Governments (RiverCOG) municipalities have experienced past flooding and other natural hazard events that pose risks to public health and safety, may cause serious property damage, and a plan is needed to address the results of these events: and

WHEREAS the planning process fostered by the Connecticut Department of Emergency Services and Public Protection, Division of Emergency Management and Homeland Security, and set forth by the Federal Emergency Management Agency, offers the opportunity to consider natural hazards and risks, and to identify mitigation actions to reduce future impacts of such hazards; and

WHEREAS the State of Connecticut has provided federal Hazard Mitigation Assistance program funds to support development of the mitigation plan; and
