It is with a tremendous amount of mixed feelings that I am writing to notify you of my resignation from the Cromwell Board of Education (BOE), effective as of June 19, 2020.

I have been honored to serve as a volunteer member on the BOE since November 2009. I have appreciated the chance to play a role in supporting our students, families, teachers, staff and administrators. Although I have been considering this decision since early this year, it has become very clear to me that with increased demands in my role as a lawyer at Pratt & Whitney, particularly in light of the COVID-19 situation, I can no longer dedicate the time necessary to effectively serve my community as a member of the BOE. I am hopeful that more community members will hear the call and volunteer to serve, bringing new perspectives and driving positive change.

I would like to especially thank all those who serve and support our students and our families – our teachers, staff, SROs, and administrators. I am lucky to have been able to work with so many skilled professionals in the Cromwell Public Schools who have dedicated their professional lives to making sure our students receive a top notch education, but, more importantly, that they help guide them to become productive citizens, well-rounded artists and athletes, and good people. Their passion and dedication has been particularly evident as they deal with the new challenges caused by COVID-19. As a father and BOE member, I am very proud of the incredible Cromwell Public Schools team.

Finally, I would like to thank the voters of Cromwell who provided me with this opportunity to serve our community. I am truly honored and humbled. I wish you continued health, happiness and success. Take care and be well.
