# **Report of The Town Manager Executive Search Committee**

July 20, 2015

Dear Cromwell Town Council,

The executive search committee was formed in December of 2014 and consisted of Deputy Mayor Newton, Mertie Terry, Shirley Banic and myself. This group was formed to begin the work of finding a new Town Manager due to the premature departure of Mr. Sistare

We began our work in January of 2015 with our first search committee meeting. The first part of our work was to determine how to proceed with a search firm. MRI who did our first search agreed to do this second search for us at no charge even though we were past the one year guarantee of their original contract with the town. The search committee agreed that this would be the best choice and we began working right away.

We had our first meeting with Mr. Jutton from MRI in January and we began the process of beginning the search for our new Town Manager. Don posted the ad and we agreed as a search committee to look at all applications that were presented by CT Candidates.

The applications began coming in and Don began the process of vetting them. From that point on MRI worked the candidate list down to 10 potential candidates that went on to answer the essay questions.

Once the essay questions were answered the executive search committee met to discuss all the candidates and see who we would want to bring forward for interviews. We agreed to interview 4 candidates and we set up the interviews for May 20<sup>th</sup>.

At a special Town Council meeting on April 29<sup>th</sup> the search committee was converted from the committee of 4 to all the members of the Town Council. We had a follow up meeting on May 5<sup>th</sup> to update and give candidate packet information to the other search committee members.

We had our interviews on May 20<sup>th</sup> where we interviewed 4 candidates throughout the whole day. All the search committee members filled out a rating sheet to rate the candidates on various abilities of what it takes to be a Town Manager. We had several follow up meetings from that point on and it was agreed to cut the list to two. We then had another meeting in early June in which town Labor Attorney was present to go over the process moving forward as we were ready to make a final decision for the position.

We had discussions regarding the two candidates and in the end it was unanimously decided that the search committee recommend Anthony Salvatore as Cromwell's next Town Manager. Tony scored the highest amongst all the candidates; he met all the qualifications set forth by the Town Charter and Town Manager job description. The search committee feels that with his years of experience in management, organization, very strong work ethic and his great knowledge of the town that he is the best fit for the town and he has all the skills necessary to be a great Town Manager for the Town.

We did have a background check done by Baker and Associates which came by the recommendation of Attorney Weinstock's firm. I can verify that the background check came back completely clean.
