F. MAYOR'S UPDATE

Mayor Faienza reported:

- He attended the Fire District meeting along with Deputy Mayor J. Donohue. The Joint Study with the Town was approved with the caveat that the Town upfront the cost until July when the Fire District will reimburse the town for their share.
- The Board of Education formed a School Sub-Committee.
- The Health Department established a Unified Command for the purpose of the Corona Virus.
- The Mayor along with the Town Manager, Health Coordinator, Representative Carpino and Senator Lesser will continue to work on the Vaping Issue. They will continue planning informational sessions and forums on the topic.
- Grand Opening for Peaceful Chaos Yoga LLC on March 27th at 1:00 p.m.
- The Cromwell Division of the Chamber will meet tomorrow at Mosaic.

G. TOWN MANAGER'S UPDATE

Town Manager Salvatore reported:

- Commended staff for the outstanding job on this year's budget.
- Building Maintenance has stepped up their cleaning and sanitizing efforts; especially in the Public areas.
- The Highway Department is working on the Community Field Road Parking Lot; the lot will provide 90+ much needed stalls for the downtown area.
- Health Coordinator S. Nesci is doing an outstanding job with the current health situation. A staff meeting was held today and it was determined that the Senior Center will remain open to Cromwell Residents Only. Weekly meetings are scheduled weekly until the situation improves
- The Recreation Brochure was mailed out this week; Recreation Director Kieras and his staff were commended for a superb job on the brochure and also the selection of Unified Programs.
- No news has been received on the closing of the Red Lion.
- Sysco is looking to expand; they may need a traffic review.
- ARCO (Scannell) received their permits.
- Shadow Lane is slated to be paved; we are waiting for 3 houses to be built so the new road won't be cut up during the construction. They are also waiting for DEEP Permits.

H. FINANCIAL/FINANCE DIRECTOR'S UPDATE

Finance Director M. Sylvester reported:

- Town Attorney Fees may exceed budget; they should be able to make the overage up using other line items. Snow expenses were very light this year.

RE: Senior Center request to charge for *specific* programs

Thank you for the opportunity to speak on behalf of the request by Amy Saada, Director of Cromwell Senior Center, to charge for *specific* programs. I am speaking as one member of the Senior Center Commission as well as a Cromwell taxpayer.

This past Monday, the Senior Center Commission met and discussed the concept of minimal charges for *specific* programs. While no vote was taken, there was general consensus that charging, as Amy has outlined, makes sense.

It is important to keep in mind that most of the programming remains free. It is this portion of programming that is covered by our taxes. However, due to Amy's excellent leadership, the Senior Center now offers more programming than in the past and there are considerably more people using these services and programs than in the past. The delight in these new programs has resulted in participants asking for even more classes and programs. Hiring new teachers is not within the scope of the existing budget. Therefore, adding programs requires either increasing the budget which will have to wait until 2021 or requires requesting minimal charges.

Also note, when any of us pay for something, we are more invested in participating. An interesting example at the Senior Center are the luncheons: when they were free, if 100 people said they would attend, perhaps only 60 would show up. Cleverly, the Senior Center instituted the following policy: pay \$5.00 up front and it would be returned when you show up for the meal. A large donation jar was available and many participants placed the \$5.00 in the jar.

As a taxpayer, I do expect certain services in return. However, I *prefer* to have *choice* in some specialty programs and pay a minimal cost instead of having my taxes raised in an overall budget increase. If I choose not to participate, I don't pay, and my taxes don't go up.

YES, the Town Council can vote to have only FREE programming at the Senior Center. This decision simply means there will be fewer programs, and fewer options. I believe if your constituents understood this, they will be delighted that you voted to include *specific* programs having a minimal fee.

Thank you for considering this worthy request.

RESOLUTION AUTHORIZING INDEMNIFICATION AND DEFENSE
