I am unable to attend tonight's public hearing regarding the upcoming Revised Charter therefore, I am requesting that my comments be read into the record.

The revised Charter is changing two elected positions, Town Clerk and Tax Collector to become appointed as of January 1, 2018. As these appointments date conflicts with their duly elected term of office ending in November 2019.

I did contact the Secretary of State's office on the legality of a duly elected office being terminated before the end of the term which voters voted on in November. I asked if there is a State Statute for this and Ted Bromley, Esq. informed me that no, not really that is why the town attorney needs to be involved. It is case law. I asked what is meant by case law – court decision not statutes.

I am requesting that our Town Attorney provide CT court decision on this before this section of the Charter is approved and put on the November ballot. I have listed all of my correspondence and replies to and from the Secretary of State office on page 2.

I fully understand that the November 2017 elected officials will be duly appointed under the terms of the Charter. That does negate that a duly elected term of office is being eliminated less than 2 months from the election.
